Report of 1% Manual Tally

Method used to choose precincts and batch of ballots to manually tally (include description of random selection method):

Placer County would need to randomly select 2 polling place precincts and 3 mail ballot precincts to comply with Elections Code Section 15360. Using the EIMS One Percent Random Sample Report five precincts were selected. We ran the report six times to get six random lists of precincts and a six-sided die was used to determine which list of precincts to use. The following precinct numbers were selected on November 9, 2022: 0254103, 356010, 0551553, 6551454 and 6551481. Further, to cover the remaining contests that were not included in the selected precincts, additional precinct numbers were drawn, and the following precincts were added: 0131101, 0131103, 0157201, 0157413, 0231153, 0257517, 0355005, 0356024, 0356038, 0451289, 0511583, 0511603, 0511817, 0511902, 0511924, 0513001, 0551520, 0552012, 6231135, and 6511601. Additionally, because 4 mail ballot precincts were selected for various races and mail ballots are not sorted down to the precinct level, we included all 10 batches of mail ballots (2,000 ballots) counted prior to 11/9 in our manual recount. At the time of the random draw, we had counted 236 batches of vote by mail ballots, mail ballots, and Uniformed and Oversea Citizens Absentee ballots. We needed to hand count a minimum of 3 batches to comply, however, we performed the manual tally on 7 batches to include all contests. We assigned those batches numbers 1 through 236 and ran a random generator on those numbers. The batches selected were 88, 91, 130, 132, 187, 194 and 220. The following batch numbers were utilized for the 1% manual tally: VBM 4 Tab 6 Batch 34 (88), VBM 2 Tab 4 Batch 37 (91), VBM 3 Tab 5 Batch 36 (130), VBM 3 Tab 5 Batch 38 (132), VBM 4 Tab 6 Batch 45 (187), VBM 4 Tab 6 Batch 52 (194), and VBM 5 Tab 7 Batch 24 (220).
