NOTICE IS FURTHER GIVEN that official Nomination Petitions and Declarations of Candidacy for eligible candidates desiring to file for the above elective offices (except city council races in the Cities of Auburn, Colfax, Lincoln, Rocklin, Roseville, and Town of Loomis) may be obtained from the Placer County Elections Office, 2956 Richardson Drive, Auburn, CA 95603 beginning July 18, 2022, Monday through Friday from 8:00AM to 5:00PM, excluding holidays. For the Tahoe area, Nomination Petitions and Declarations of Candidacy may be picked up at the Customs House Building located at 775 North Lake Blvd., Tahoe City on Tuesday and Thursday, August 2, 4, 9, and 11 from 11:00AM to 3:00PM, excluding holidays. Completed documentation shall be returned to the Placer County Elections Office during normal business hours or for Tahoe filers, the Customs House Building only during the timeframe listed above. Candidates for Auburn, Colfax, Lincoln, Loomis, Rocklin, and Roseville offices must obtain their nomination paperwork from their respective City/Town Clerk. Contact the appropriate City/Town Clerk's office for more information.

NOTICE IS FURTHER GIVEN that filing is open Monday, July 18, 2022, and will close Friday, August 12, 2022, after which time no candidate filing documentation will be accepted. If an incumbent does not file his or her declaration of candidacy on or before August 12, 2022, the period for all non-incumbents to obtain and return their candidate paperwork will extend to August 17, 2022. Candidate paperwork for extended filing can be picked up and filed at the Placer County Elections Office hours are 8:00AM to 5:00PM.

NOTICE IS FURTHER GIVEN that appointment to each elective office will be made as

prescribed by Section 10515 in the event there are no nominees or an insufficient number of nominees for the office and a petition for an election is not filed with the elections official within the period prescribed by Section 10515 of the Elections Code.

NOTICE IS FURTHER GIVEN that consolidated with the General Election the following measure shall be put to a vote of the qualified voters within their jurisdiction:

Measure B – City of Colfax:

TRANSIENT OCCUPANCY TAX INCREASE

To support essential City services, including police, fire, road and pothole repair, and parks and recreation, shall the measure increasing the Transient Occupancy Tax (paid only by hotel/motel/short-term rental guests) rate from 8% to 10% and expanding the obligation to collect Transient Occupancy Tax to all persons receiving compensation from such rentals, generating an estimated \$29,000 annually until ended by the voters, be adopted?

Measure C – City of Roseville:

To continue local funding that cannot be taken by the State for City of Roseville essential services such as: 911 emergency response; repairing potholes and streets; neighborhood police patrols; fire protection; addressing blight; and maintaining existing city amenities; shall the measure increasing Roseville's existing transient occupancy tax (paid only by hotel and lodging guests) from 6% set in 1975 to 10% providing an estimated additional \$3 million annually, with independent audits, until ended by voters, be adopted?

Measure E – Auburn Union School District:

To retain/ attract quality teachers, provide students with a well-rounded education in science, technology and engineering/math by upgrading deteriorating classrooms/schools, removing asbestos/lead paint, repairing roofs and gas lines/electric wiring and maintaining safe school drinking water, shall the Auburn Union School District issue \$45,000,000 in bonds at legal rates, annually levying approximately \$28 per \$100,000 of assessed valuation, generating approximately \$2,500,000 annually while bonds are outstanding, requiring audits/public spending disclosure?

Measure F – City of Rocklin:

Hotel and Lodging Definition and Tax Measure

To maintain local funding for essential services including: Police and Fire/Emergency Medical Service response, street/road repair, and park maintenance in the City of Rocklin, shall a measure expanding the definition of hotel to include campgrounds, and increasing the existing Transient Occupancy Tax (paid by hotel/lodging guests) from 8% to 10%, providing an estimated \$300,000 annually, with independent audits, until ended by voters, be adopted?

Measure G – Western Placer Unified School District:

To renovate/ modernize Carlin Coppin and Creekside Oaks Elementary Schools, Lincoln and Phoenix High Schools; complete Twelve Bridges High School; remove/ replace asbestos, lead pipes, roofs, electrical systems; supporting achievement in math, science, engineering, reading, arts and technology; improve safety / security / disabled access; prevent overcrowding; shall Western Placer Unified School District issue \$185,000,000 in bonds at legal rates, annually levying approximately \$54 per \$100,000 of assessed valuation, generating approximately \$9,400,000 annually while bonds are outstanding, requiring audits/citizens oversight?

Measure J – Twin Rivers Unified School District:

Twin Rivers Unified School District Middle/High School Health/ Safety/ Repair Measure. Shall the measure of Twin Rivers Unified School District be adopted to repair heating/ air conditioning/ electrical systems; provide safe drinking water/ playgrounds; remove asbestos/ mold/ lead paint; repair leaky roofs; improve security systems; construct classrooms; by authorizing \$120 million in bonds at legal interest rates, levies of 2.3¢ per \$100 assessed value, raising approximately \$8 million annually while bonds are outstanding, requiring oversight, annual audits, all funds benefitting local schools?

Measure K – Twin Rivers Unified School District:

Twin Rivers Unified School District Elementary SFID Student Health/Safety Repair Measure. Shall the measure of Twin Rivers Unified School District's SFID be adopted to upgrade heating/air conditioning/electrical systems; provide safe drinking water/ playgrounds; repair blacktop /leaky roofs, outdated classrooms/ bathrooms/ kitchens; remove mold/asbestos/lead paint; by authorizing \$150 million in bonds at legal interest rates, levies of 3.7¢ per \$100 assessed value, raising approximately \$10 million annually while bonds are outstanding, requiring oversight, annual audits, all funds benefitting local schools?

NOTICE IS FURTHER GIVEN that direct arguments for or against said measure(s) shall be submitted to the Placer County Elections Office. Said arguments shall not exceed 300 words in length and may be received or withdrawn, but not changed, prior to and including August 12, 2022, at 5 PM. The Placer County Registrar of Voters shall cause (if submitted) one argument for and/or one argument against said measure(s) to be printed and shall cause to be enclosed a copy thereof in each county voter information guide. If multiple arguments are submitted either for or against a measure, the Placer County Registrar of Voters shall choose and print one argument in accordance with applicable law or procedure. City/Town measure arguments are filed with the City/Town Clerk's office. The cities of Auburn, Colfax, Lincoln, Rocklin, and the Town of Loomis follow the above deadlines for measures. Primary arguments for the City of Roseville's measure are due July 20, 2022, and rebuttals are due August 9, 2022. Please reach out to the City/Town Clerk to verify applicable deadlines.

NOTICE IS FURTHER GIVEN that, for individuals interested in submitting arguments for or against said measure(s), the physical address for the Placer County Elections Office is 2956 Richardson Drive in Auburn. The mailing address for the Placer County Elections Office is PO Box 5278, Auburn, CA 95604.

NOTICE IS FURTHER GIVEN that when the Placer County Registrar of Voters has selected the direct arguments for and against said measure(s), the Placer County Registrar of Voters shall send copies of the argument in favor of said measure(s) to the authors of the argument against and copies of the argument against to the authors of the argument in favor. The authors may prepare and submit rebuttal arguments not to exceed 250 words. The rebuttal arguments must be filed with the Placer County Registrar of Voters not later than 10 days after the final date for filing direct arguments. The final date for rebuttal arguments is August 22, 2022, at 5 PM. City/Town measure rebuttal arguments are filed with the City/Town Clerk's office. The cities of Auburn, Colfax, Lincoln, Rocklin, and the Town of Loomis follow the above deadlines. The City of Roseville's deadline for primary arguments is July 20, 2022, and their deadline for rebuttals is August 9th, 2022. For the most accurate information, please reach out to the City/Town Clerk to verify applicable deadlines.

NOTICE IS FURTHER GIVEN that California Elections Code Section 9600 governs the form of said arguments and/or rebuttals. Arguments and/or rebuttals submitted to the Placer County Elections Office must follow this form. Authors of said arguments/rebuttals may call the Elections Office at 530-886-5650 for more information and a copy of this Elections Code Section.

NOTICE IS FURTHER GIVEN that the Random alphabet draw will be held on August 18, 2022, at 11 AM to determine the ballot order of candidates' names.

NOTICE IS FURTHER GIVEN that the last day to register to vote for the General Election is October 24, 2022. Conditional Voter Registration is available beginning October 25, 2022 through Election Day for those that missed the registration deadline and want to register to vote and receive a ballot the same day.

NOTICE IS FURTHER GIVEN that in accordance with Assembly Bill 37 (AB 37), every registered voter shall be mailed a ballot no later than 29 days prior to the day of the Election. AB 37 amended Sections 3000.5, 3016.7, 3019.7, 3020, and 15101, added Section 3025.5, and repealed Section 3016.5 of the California Elections Code. Ballots will be mailed to all active registered voters by October 10, 2022. Additionally, remote accessible voting shall be available to all registered voters.

NOTICE IS FURTHER GIVEN that the last day for the Elections Office to mail a requested ballot is November 1, 2022.

NOTICE IS FURTHER GIVEN that at the General Election the polls will be open from the hour of 7:00 AM to the hour of 8:00 PM on the day thereof.

NOTICE IS FURTHER GIVEN that after the polls are closed on the date of said election, the ballots will be transported to the central counting location at the Placer County Elections Office, 2956 Richardson Drive, Auburn, CA 95603.

NOTICE IS FURTHER GIVEN that the opening and processing of the vote-by-mail ballots for said election will take place at the Placer County Elections Office starting October 10, 2022, and continue through Election Night, November 8, 2022.

NOTICE IS FURTHER GIVEN that the canvass will commence on or before 8:00 AM on November 9, 2022, at the Placer County Elections Office.

NOTICE IS FURTHER GIVEN that the Elections Office will be open for business the two weekends prior to the General Election (October 29 and 30 / November 5 and 6 from 9:00AM to 4:00PM).

NOTICE IS FURTHER GIVEN, in accordance with provisions of the election laws of the State of California, that on November 9, 2022, at 10:00 AM, the Placer County Elections Office will randomly select precincts for a manual tally of one percent (1%) of the precincts casting ballots at the November 8, 2022, General Election.

NOTICE IS FURTHER GIVEN that this random selection of precincts is open to the public.

NOTICE IS FURTHER GIVEN that on November 16, 2022, at 9:00 AM, the Placer County Elections Office will begin a manual tally of one percent (1%) of the precincts casting ballots at the November 8, 2022, General Election.

NOTICE IS FURTHER GIVEN that this manual tally is open to the public and shall continue daily (Saturdays, Sundays and holidays excluded unless otherwise decided by the County Registrar of Voters) until completed.
